# PART 2: SAVE AS YOU EARN PLAN

The following is a summary of the main provisions of the SAYE Plan proposed to be adopted by the Company pursuant to Resolution 13.

This Part summarises the SAYE Plan, but does not form part of the rules of the SAYE Plan ("**Rules**") and should not be taken as affecting the interpretation of the detailed terms and conditions constituting the Rules.

The Rules will be available for inspection at the registered office of the Company (at Manor Mill, Victoria Street, Chadderton, Oldham, OL9 0DD) during usual business hours on any weekday (Saturday, Sunday and public holidays in the United Kingdom excluded) from the date of this Notice until the end of the Annual General Meeting and will be available for inspection at the place of the Annual General Meeting for at least 15 minutes prior to and during the Annual General Meeting.

# General

The SAYE Plan is a savings related share option scheme that has been designed to take advantage of the taxadvantaged status of savings-related share option schemes which comply with Schedule 3 to the Income Tax (Earnings and Pensions) Act 2003 ("**Schedule 3**").

The SAYE Plan will be operated and supervised by the Remuneration Committee of the Board (the "Committee").

# Eligibility

All UK employees and full-time Directors of the Company and participating companies within the Group are eligible to participate in the SAYE Plan. It is intended that invitations to apply for options over Ordinary Shares ("**Options**") under the SAYE Plan will be made to all eligible employees and full-time Directors who are employed by the Company and participating companies within the Group on the date invitations under the SAYE Plan are issued. The Committee will determine the basis upon which any invitations to apply for Options are made.

# **Savings Contract**

To participate in the SAYE Plan, an eligible employee must enter in a save-as-you-earn contract (**"Savings Contract**") with the savings body designated by the Committee, agreeing to make monthly contributions of between £10 and £500 (or such other amounts as are specified by the Committee, in respect of any particular invitation, such amounts being compliant with Schedule 3) of a specified savings period of three or five years. The Committee has discretion to determine which of the Savings Contracts will be available in respect of any invitation to apply for Options.

A bonus determined by HM Revenue & Customs is payable after the expiration of the savings period.

Applications to participate in the SAYE Plan may be scaled down by the Committee, if applications exceed the number of Ordinary Shares available for the grant of Options. Such scaling down may include:

- the exclusion of bonuses;
- reducing monthly contributions above a certain level pro rata;
- reducing monthly contributions for each eligible employee pro rata; or
- treating elections for five-year Saving Contracts as elections for three-year Savings Contracts.

# **Option Price**

The exercise price for each Ordinary Share in respect of which an Option is granted ("**Option Price**") shall not be less than the greater of:

- 80 per cent of the average middle-market quotation as derived from the London Stock Exchange Daily Official List for the dealing day prior to the date of grant; and
- the nominal value of the Ordinary Shares.

## **Issue of Invitations**

Invitations to apply for Options may only be made within the period of 42 days following the approval of the SAYE Plan by the Company's shareholders, the announcement of the Company's results for any period, from any day on which changes to the legislation or regulations affecting save as you earn schemes under Schedule 3 are announced, effected or made or any day on which the Committee determines that exceptional circumstances exist.

If, during any such period, the Company is restricted from issuing invitations, invitations may be made immediately following the date on which such restrictions cease to apply.

## **Grant of Options**

The number of Ordinary Shares over which Options may be granted must, as nearly as possible, be equal to, but not in excess of, that number of Ordinary Shares which may be purchased out of the repayment proceeds (including, any interest or bonus payable) of the relevant Savings Contract at the Option Price.

#### **Exercise of Options**

The authority granted by this resolution will expire at the conclusion of the Company's next annual general meeting after the passing of this resolution or, if earlier, at the close of business on 31 January 2020, save that the Company may, before such expiry make offers or agreements which would or might require equity securities to be allotted (or treasury shares to be sold) after the authority expires and the Directors may allot equity securities (or sell treasury shares) in pursuance of any such offer or agreement as if the authority had not expired.

# EXPLANATORY NOTES

## **Resolution 1 – Receive and approve the reports and accounts**

Shareholders are being asked to receive and approve the Annual Report and Accounts of the Group and the Company (as audited by BDO LLP) for the year ended 31 July 2018 together with the associated reports of the directors and the auditor.

## **Resolution 2 – Directors' Remuneration Report**

Resolution 2 invites Shareholders to approve the annual statement by the chairman of the Remuneration Committee and the Directors' Remuneration Report for the year ended 31 July 2018 (set out on pages 47 to 49 and 66 to 78 of the Annual Report and Accounts respectively). In line with legislation, Resolution 2 is an advisory vote and the Directors' entitlement to remuneration is not conditional on the resolution being passed.

## Resolution 3 – Final dividend

Shareholders are being asked to approve a final dividend of 1.89 pence per ordinary share of 0.25 pence for the year ended 31 July 2018 If Shareholders approve the recommended final dividend, it will be paid on 30 January 2018 to all Shareholders on the Company's register of members on 4 January 2018.

#### **Resolutions 4 to 10 inclusive – Re-election of Directors**

The Board complies with the provisions of the UK Corporate Governance Code whereby all Directors are subject to annual re-election. Accordingly, all Directors of the Company are retiring and offering themselves for re-election.

Each of the Directors standing for election has demonstrated that he or she remains committed to the role, has the necessary skills and experience, and continues to be an effective and valuable member of the Board. In considering the independent Non-Executive Directors' independence, the Board has taken into consideration the guidance provided by the UK Corporate Governance Code. The Board considers James McCarthy, Alan Rigby and Robbie Bell to be independent in accordance with Provision B.1.1 of the UK Corporate Governance Code and there are no relationships or circumstances likely to affect their character or judgement. Accordingly, the Board unanimously recommends the election of the Directors set out in Resolutions 4 to 10.

#### Resolutions 11 and 12 – Auditor Appointment and Remuneration

The auditors of a company must be reappointed at each general meeting at which accounts are presented. Resolution 11 proposes the reappointment of BDO LLP as auditors of the Company. The Board, on the recommendation of the Audit Committee, recommends the reappointment of BDO LLP and BDO LLP has agreed to continue as the Company's Auditor until the conclusion of the next AGM at which the accounts are laid before the Company. In accordance with best practice, Resolution 12 is a separate resolution which gives authority to the Audit Committee to determine the auditor's remuneration.

# Resolution 13 - To approve the Company's SAYE Plan

Resolution 13 relates to the proposal to adopt a new employee share option plan to incentivise the Company's UK employees and full-time Directors. The reasons for the proposal of the SAYE are described in Part 1 of this document and a summary of the principal terms of the SAYE Plan is set out on in Part 2 of this document.

The rules of the SAYE Plan will be available for inspection at the Company's registered office (at Manor Mill, Victoria Street, Chadderton, Oldham, OL9 0DD) during usual business hours on any weekday (Saturday, Sunday and public holidays in the United Kingdom excluded) from the date of this Notice until the end of the Annual General Meeting and will be available for inspection at the place of the Annual General Meeting for at least 15 minutes prior to and during the Annual General Meeting.

# **Resolution 14 – Authority to allot shares**

This resolution complies with the Investment Association Share Capital Management Guidelines issued in July 2016. The Directors may not allot shares in the Company unless authorised to do so by Shareholders in general meeting. If passed, the resolution will authorise the Directors to allot: (i) in relation to a pre-emptive rights issue only, equity securities (as defined by section 560 of the CA 2006) up to a maximum nominal amount of £135,000 which represents approximately two-thirds of the Company's issued Ordinary Shares (excluding treasury shares) as at 9 November 2018 (being the latest practicable date prior to the publication of this document). This maximum is reduced by the nominal amount of any Relevant Securities allotted under the authority set out in Resolution 14(b); and (ii) in any other case, Relevant Securities up to a maximum nominal amount of £67,500 which represents approximately one-third of the Company's issued Ordinary Shares (excluding treasury shares) as at 9 November 2018 (being the latest practicable date prior to the publication of this document). This maximum is reduced by the nominal amount of the Company's issued Ordinary Shares (excluding treasury shares) as at 9 November 2018 (being the latest practicable date prior to the publication of this document). This maximum is reduced by the nominal amount of any equity securities allotted under the authority set out Resolution 14(a) in excess of £67,500.

The maximum nominal amount of Relevant Securities (including equity securities) which may be allotted under this resolution is £135,000, subject to the limitations explained above.

As at close of business on 9 November 2018 (being the latest practicable date prior to the publication of this document), the Company did not hold any treasury shares.

The Directors have no present intention to exercise the authority sought under sub-paragraph (a) of Resolution 14. However, if such authority is obtained, it will give the Company greater flexibility to allot additional shares for the purpose of a pre-emptive rights issue. This authority will be used when the Directors consider it to be in the best interests of Shareholders.

The authorities sought under Resolution 14 will expire on the earlier of 31 January 2020 (being the latest date by which the Company must hold its annual general meeting in respect of the year ending on 31 July 2018) and the conclusion of the annual general meeting of the Company in respect of the year ending on 31 July 2018.

## **Resolution 15 – Disapplication of statutory pre-emption rights**

If the Directors wish to allot new shares for cash, the CA 2006 states that the shares must be offered first to existing Shareholders in proportion to their existing shareholdings. For legal, regulatory and practical reasons, it might not be possible or desirable for shares allotted by means of a pre-emptive offer to be offered to certain Shareholders, particularly those resident overseas. Furthermore, it might, in some circumstances, be in the Company's interests for the Directors to be able to allot some shares for cash without having to offer them first to existing Shareholders. To enable this to be done, Shareholders' statutory pre-emption rights must be disapplied. Accordingly, Resolution 15, if passed, will empower the Directors to allot a limited number of new equity securities without Shareholders' statutory pre-emption rights applying to such allotment. The authority conferred by Resolution 15 would also cover the sale of treasury shares for cash.

Sub-paragraph (a) of Resolution 15 would confer authority on the Directors to allot equity securities (as defined by section 560 of the CA 2006) or sell treasury shares for cash without first offering them to existing Shareholders in proportion to their existing holdings in relation to pre-emptive offers and offers to holders of other equity securities if required by the rights of those securities, up to a maximum nominal amount of £67,500 which represents approximately one-third of the Company's issued ordinary share capital (excluding treasury shares) as at 9 November 2018 (being the latest practicable date prior to the publication of this document) and, in relation to rights issued ordinary share capital (excluding treasury shares) as at 9 November 2018 (being the latest practicable date prior to the publication of this document) and, in relation to rights issued ordinary share capital (excluding treasury shares) as at 9 November 2018 (being the latest practicable date prior to the publication of the company's issued ordinary share capital (excluding treasury shares) as at 9 November 2018 (being the latest practicable date prior to the publication of the company's issued ordinary share capital (excluding treasury shares) as at 9 November 2018 (being the latest practicable date prior to the publication of this document).

Sub-paragraph (b) of Resolution 15 would confer authority on the Directors to allot equity securities (as defined by section 560 of the CA 2006) or sell treasury shares for cash without first offering them to existing Shareholders in any other case, but subject to a maximum aggregate nominal value of £10,250, representing approximately 5% of the Company's issued share capital as at 9 November 2018 (being the latest practicable date prior to the publication of this document).

This resolution is in line with guidance issued by the Investment Association (as updated in July 2016) and the Pre-Emption Group's Statement of Principles (as updated in March 2015) (the **Statement of Principles**), and the template resolutions published by the Pre-Emption Group in May 2016.

The Directors have no present intention to exercise the authority conferred by this resolution. The Directors also confirm that in accordance with the Statement of Principles, they do not intend to issue shares for cash representing more than 7.5% of the Company's issued ordinary share capital in any rolling three-year period other than to existing Shareholders unless Shareholders have been notified and consulted in advance.

The authority sought under Resolution 15 will expire on the earlier of 31 January 2020 (being the latest date by which the Company must hold its annual general meeting in respect of the year ending on 31 July 2019) and the conclusion of the annual general meeting of the Company in respect of the year ending on 31 July 2019.

## **Resolution 16 – Purchase of own shares**

The CA 2006 permits a company to purchase its own shares provided the purchase has been authorised by Shareholders in general meeting. Resolution 16, if passed, would give the Company the authority to purchase any of its own issued Ordinary Shares at a price of not less than an amount equal to the nominal value of an ordinary share and not more than the higher of: (i) 5% above the average of the middle market quotations of the Company's Ordinary Shares as derived from the London Stock Exchange Daily Official List for the five dealing days before any purchase is made; and (ii) the value of an Ordinary Share calculated on the basis of the higher of the price quoted for (a) the last independent trade of; and (b) the highest current independent bid for, any number of the Company's Ordinary Shares on the trading venue where the purchase is carried out.

The authority will enable the purchase of up to a maximum of 8,216,960 Ordinary Shares, representing 10% of the Company's issued Ordinary Shares as at 9 November 2018 (being the latest practicable date prior to the publication of this document) and will expire on the earlier of 31 January 2020 (being the latest date by which the Company must hold its annual general meeting in respect of the year ending on 31 July 2019) and the conclusion of the annual general meeting of the Company in respect of the year ending on 31 July 2019.

The Directors will only exercise the authority to purchase Ordinary Shares where they consider that such purchases will be in the best interests of Shareholders generally and will result in an increase in earnings per ordinary share. Purchases are expected to be financed out of distributable profits and shares purchased will either be cancelled (and the number of shares in issue reduced accordingly) or held as treasury shares. The Directors believe that holding shares in treasury would provide the Company with greater flexibility in the management of its share capital. The Directors will also consider using any treasury shares to satisfy share options/awards under the Company's employees' share schemes.

As at 9 November 2018, the Company did not hold any treasury shares.

Simon Showman, Andrew Gossage and Barry Franks (the "**Concert Party**") are currently interested in an aggregate of 33,853,400 Ordinary Shares, representing 41.20 per cent of the issued share capital of the Company (excluding treasury shares) as at 9 November 2018 (being the latest practicable date prior to the publication of this Notice). If the Company were to re-purchase from persons other than the Concert Party all Ordinary Shares for which it is seeking authority, the Concert Party's interest in shares would (assuming no other allotment of ordinary shares) increase to 45.78 per cent of the issued share capital of the Company by virtue of such action (excluding treasury shares).

Under Rule 37 of the City Code, when a company purchases its own voting shares, any resulting increase in the percentage of shares carrying voting rights in which a person or group of persons acting in concert is interested will be treated as an acquisition for the purpose of Rule 9 of the City Code. # General Notes

#### 1. Attending the Annual General Meeting in person

If you wish to attend the Annual General Meeting in person, you should arrive at the venue for the Annual General Meeting in good time to allow your attendance to be registered. It is advisable to have some form of identification with you as you may be asked to provide evidence of your identity to the Company's registrar, Equiniti Limited (the "**Registrar**"), prior to being admitted to the Annual General Meeting.

#### 2. Appointment of proxies

Shareholders are entitled to appoint one or more proxies to exercise all or any of their rights to attend, speak and vote at the Annual General Meeting. A proxy need not be a Shareholder of the Company but must attend the Annual General Meeting to represent a Shareholder. To be validly appointed, a proxy must be appointed using the procedures set out in these notes and in the notes to the accompanying Proxy Form.

Details of how to appoint the Chairman of the Annual General Meeting or another person as your proxy using the Proxy Form are set out in the notes to the Proxy Form. If you wish your proxy to speak on your behalf at the Annual General Meeting you will need to appoint your own choice of proxy (not the Chairman) and give your instructions directly to them. Such an appointment can be made using the Proxy Form accompanying this notice of Annual General Meeting or through CREST.

Shareholders can only appoint more than one proxy where each proxy is appointed to exercise rights attached to different shares. If you do not have a Proxy Form and believe that you should have one, or you require additional Proxy Forms, please contact the Registrar at Equiniti Limited, Aspect House, Spencer Road, Lancing BN99 6DA.

#### 4. Appointment of a proxy through CREST

CREST members who wish to appoint a proxy or proxies through the CREST electronic proxy appointment service may do so by using the procedures described in the CREST Manual and by logging on to: www.euroclear.com. CREST personal members or other CREST sponsored members and those CREST members who have appointed (a) voting service provider(s) should refer to their CREST sponsor or voting service provider(s) who will be able to take the appropriate action on their behalf.

In order for a proxy appointment or instruction made using the CREST service to be valid, the CREST Proxy Instruction must be properly authenticated in accordance with Euroclear's specifications, and must contain the information required for such instruction, as described in the CREST Manual. The message, regardless of whether it constitutes the appointment of a proxy or is an amendment to the instruction given to a previously appointed proxy, must, in order to be valid, be transmitted so as to be received by the Registrar (ID RA19) no later than 48 hours before the time of the Annual General Meeting or any adjournment of that meeting. Any changes to the Company's register of members after the relevant deadline will be disregarded in determining the rights of any person to attend and vote at the Annual General Meeting.

#### 8. Nominated persons

Any person to whom this notice is sent who is a person nominated under section 146 of the CA 2006 to enjoy information rights (a "**Nominated Person**") may, under an agreement between him/her and the Shareholder by whom he/she was nominated, have a right to be appointed (or to have someone else appointed) as a proxy for the Annual General Meeting. If a Nominated Person has no such proxy appointment right or does not wish to exercise it, he/she may, under any such agreement, have a right to give instructions to the Shareholder as to the exercise of voting rights.

#### 9. Website giving information regarding the AGM

## 10. Audit concerns
